



## **Investment Options:**

Antigua & Barbuda's Citizenship by Investment program requires investors to contribute to the National Development Fund or invest into Real Estate projects or a government approved business in return for a citizenship and passport.

#### Contribution to the National Development Fund (NDF)

The government has recently reduced the required contribution amount to only \$100,000 USD (family of 4) and \$125,000 USD (family of 5 or more).

#### **Government Processing Fees (USD):**

- \$30,000 Family of 4 (or less)
- \$15,000 For each additional qualifying dependent

#### Real Estate Investment

Make an investment in designated, officially approved real estate with a value of at least US\$ 400,000 to qualify for citizenship under the real estate option.

In addition, two applications from related parties can make a joint investment in real estate, with each applicant investing a minimum of \$200,000 USD in order to qualify.

Third pathway under real estate option where the full purchase price of a unit shall be no less than \$200,000 USD, effective 1st of April 2020.

#### Business Investment

Applicants can also choose to make a business investment of at least \$1,500,000 USD. The investment must be in an approved business. Alternatively, applicants can invest a minimum of \$400,000 USD in a co-shared investment totaling a minimum of \$5,000,000 USD.

#### **Government Processing Fees (USD):**

- \$30,000 Family of 4 (or less)
- \$15,000 For each additional qualifying dependent

#### Investment in the University of the West Indies Fund

Make an investment of \$150,000 USD for a family of 4 or more in the University of the West Indies Fund, which will entitle one member of the family to a one year, tuition only, scholarship at the University of the West Indies.

#### **Government Processing Fees (USD):**

- N/A Family of 6 & below (inclusive on the Investment Fee of USD 150,000)
- \$15,000 For each additional qualifying dependent (family of more than 6)

In addition, the following changes will apply for all investment options:

#### Due Diligence Fees (USD):


- \$7,500 Main applicant
- \$7,500 Spouse
- \$4,000 Dependents over 18 years and over
- \$2,000 Dependents 12 17 years

#### Passport Fees (USD):

• \$300 - Each family member

#### NOTES

- Both parents must be fully dependent on the main applicant or spouse and living in the same household.
- Additional charges apply and all fees are subject to change at any time without notice.



## Steps & Timeline:

#### **Initial Consultation**

The first step is a complimentary consultation with us where we explain all the different options available.

#### **Preliminary Due Diligence**

Raizing Citizen performs a preliminary due diligence, security check, before officially making any agreement as a guarantee that the applicant's record is clean from any case that the Citizenship by Investment Unit might reject his/her application for.

#### **Agreement & Fees**

Fees include legal, due diligence, government and application processing fees.

#### **Select Property (Real Estate Option)**

Once the property has been selected, the developer is notified and a sales agreement is prepared.

#### **Collect Documents & Submit File**

We will help obtain/translate and authenticate all necessary documents. A file is then prepared and submitted to the

Citizenship by Investment Unit (CIU), which usually takes approximately 10 business days from the date the file is prepared.

#### Wait for Approval

Approximately 2-4 months.

#### **Extra Documents**

The Citizenship by Investment Unit (CIU) may request additional documents or information.

#### **Approval**

Once approval has been granted, the applicant must complete all payments to obtain citizenship certificates within 30 days.

#### **Passport**

After receiving the citizenship certificate, the process of issuing passports takes approximately 5-10 business days.

NOTE: Timeline is an estimate only, processing time depends on the complexity of each file.

- 2. HIV, urine & blood medical report for all family members
- 3. 12 month bank statement & bank reference letter
- 4. Character reference letter
- 5. Employment confirmation letter (if main applicant is an employee)
- Enrollment letter or certificate from current university for dependent children 18-25 years of age confirming they are full time students at that institution
- 7. Police certificates for every country lived in for more than 6 months over the past 10 years. Main applicant, spouse

- dependents & dependent children 18 years and above need to provide police certificates
- 8. 10 passport size photos for all family members
- 9. Signed power of attorney
- Signed affidavit of financial support for children 18-25 years old and parents over 65 years (notarized)
- 11. 4 sets of signed property purchase agreement (real estate investment option)
- 12. Signed client agreement
- 13. Completed questionnaire for all family members

## **Certified Copies:**

- Colored passport copies for all family members (with valid residence visa page, if applicable)
- 2. Birth certificates for all family members
- 3. Marriage certificate
- 4. Divorce documents (if applicable)
- 5. Custody documents (notarized, if applicable)
- 6. Personal ID or national ID for all family members

- Business registration/license AND memorandum of association issued by the local government confirming the registration of the business (if self employed)
- Education certificate for the main applicant, spouse and dependents claiming the attainment of a university degree
- 9. 2 documents as proof of residential address for main applicant and for any dependents living at a different address
- 10. Military certificate or documents (if applicable)




