Investment Options:

Canada Start-Up Visa Program is a Canadian Permanent Residence Program administered by the federal government of Canada. It targets immigrant entrepreneurs with the skills and potential to build innovative and globally competitive businesses in Canada

- Have moderate proficiency in English or French (min. CLB 5 in all categories).
- Convince an angel investor to invest at least \$75,000 CAD in the start up business
- Receive a Letter of Support from a designated organization
- · Be between ages 20 and 65 years;

Steps & Timeline:

Initial Consultation

The first step is a complementary consultation with us where we explain all the different options available.

Review Applicant's Qualifications

Raizing Citizen will evaluate the applicant's qualifications. Preliminary Due Diligence. Raizing Citizen performs preliminary due diligence, a security check, before officially making any agreement as a guarantee that the applicant's record is clean from any case that the government might reject his/her application for.

Agreement and Fees

Fees include legal, due diligence, government and application processing fees. Fees are paid in stages, and the payment schedule is communicated directly to the client.

Match the Applicant with a Designated Angel Investor

Once the angel investor approves the applicant's business and invest minimum \$75,000 CAD in the business and will issue a Letter of Support to the applicant.

Apply for Permanent Residence

Submit the complete application for Permanent Residence Visa to the Centralized Intake Office for Immigration, Refugees and Citizenship Canada (IRCC). IRCC will review the documents, and also conduct the medical and security background checks.

Submit the Work Permit Application (optional)

If the applicant wishes to come to Canada right away, the applicant will have to be deemed essential to the project and will be able to apply for a Work Permit. All essential members of the group that want to apply for a Work Permit should apply at the same time. Nonessential members to the project must wait for their PR application to be approved before travelling to Canada. Once the Work Permit is received, the applicant and his/her family will come to Canada and operate the business while awaiting Permanent Residence.

(Note that the Work Permit application will be sent to the Centralized Intake Office for Immigration, Refugees and Citizenship Canada (IRCC).

Land and Establish the Business

Upon landing in Canada as Permanent Residents, the family will have access to the free public-school system, and healthcare.


