



Investment Options:

The Grenada Citizenship by Investment Program seeks to attract foreign individuals who will be entitled to obtain citizenship and a passport in a period of approximately 3 months, in exchange for an investment in either the National Transformation Fund (NTF) or another government-approved project.

 Non-refundable Payment to Grenada National Transformation Fund (NTF)

The applicant must make a minimum payment of \$150,000 USD into the NTF.

Contributions to the (NTF) program are scaled as follows (USD):

- \$150,000 Single applicant
- \$200,000 Principal applicant & spouse
- \$200,000 Family of 4
- \$25,000 Each additional dependent

Investment in an Approved Project in Grenada

A minimum investment of \$220,000 USD (for each share in a unit) by two or more individuals is required in a GCBI approved project valued at a total minimum of \$440,000 USD. This new price is only applicable in cases where applicants co-invest in a unit. Secondary purchasers of real estate units in approved projects are also eligible to obtain citizenship.

Government Fees (USD):

- \$50,000 Government fee for a family of up to four persons
- \$25,000 For each additional dependent child and/or each dependent parent and/or grandparent

In addition, the following charges will apply for all investment options:

Processing & Application Fees (USD):

- \$1,500 Application fee for Citizenship \ by Investment (per person)
- \$1,500 Processing fee per person (except dependent children under 18—their fee is \$500/person)

Due Diligence Fees (USD):

- \$5,000 USD Principal applicant
- \$5,000 USD Spouse
- \$5,000 USD Dependents 17-30 years old
- \$5,000 USD Dependent parents and/or grandparents

NOTES:

- Parent and grandparent dependents are not required to be financially dependent on the main applicant.
- Additional charges apply and all fees are subject to change at any time without notice.



Steps & Timeline:

Initial Consultation

The first step is a complimentary consultation with us where we explain all the different options available.

Preliminary Due Diligence

Raizing Citizen performs a preliminary due diligence, security check, before officially making any agreement as a guarantee that the applicant's record is clean from any case that the Citizenship by Investment Unit might reject his/her application for.

Agreement & Fees

Fees include legal, due diligence, government and application processing fees.

Choose Property (Real Estate Option)

Once the property has been chosen the developer is notified to prepare a purchase and sale agreement.

Collect Documents & Submit File

We will help obtain/translate and authenticate all necessary documents. A file is then prepared and submitted to the

Required Documents:

- 1. Draft of application forms (provided by Raizing Citizen)
- 2. HIV medical report for all family members
- 3. 2 month bank statement & bank reference letter
- 4. Character reference letter
- 5. Employment confirmation letter (if main applicant is an employee)
- 6. Recent utility bill, tenancy contract, or bank statement showing full name and residential address
- 7. Police certificates from country of birth and every country you have lived in for more than 1 year over the past 10 years. Main applicant, spouse, dependents and dependent children 16 years and above need to provide police certificates

Certified Copies:

- 1. Colored Passport copies for all family members (with valid residence visa page, if applicable)
- 2. Birth Certificates for all family members
- 3. Marriage Certificate
- 4. Divorce documents (if applicable)
- 5. Custody documents (notarized, if applicable)
- 6. Personal ID or national ID for all family members

the Citizenship by Investment Unit, which usually takes approximately 10 business days from the date the file is prepared.

Wait for Approval Approximately 2-4 months.

Extra Documents

The Grenada Citizenship by Investment Committee (CBIC) may request additional documents or information.

Approval

Once approval has been granted, the applicant must complete all payments to obtain citizenship certificates within 60 days.

Passport

After receiving the citizenship certificate, the process of issuing passports takes approximately 5-10 business days.

NOTE: Timeline is an estimate only, processing time depends on the complexity of each file.

- 8. 8 passport size photos for all family members
- 9. Signed power of attorney
- 10. Signed affidavit of financial support (notarized)
- 11. 4 sets of signed property purchase agreement (real estate investment option)
- 12. Signed client agreement
- 13. Updated CV from main applicant
- 14. Completed questionnaire for all family members

- 7. Education certificate for the main applicant, spouse and dependents with a university degree
- Business registration/license AND memorandum of association issued by the local government confirming the registration of the business (if self employed)
- 9. Military certificate or documents (if applicable)

NOTE: The government of Grenada may request additional documents and/or information not listed above.


