**Short Term Visa**- Short-term Schengen Visa applications (up to 90 days)

#### For India

- Business/ Conference
- Visiting Family/Friend
- Cultural Event

Visa Categories	Overview
Business/ Conference	Business visa application is applicable in case you are travelling for business purposes. This visa is given for travel period of less than 90 days. This visa will be issued for business purpose only; for gainful professional activities (even if the work is not financially rewarded) you have to apply for a work permit.
Visiting Family/Friend	Visit to family or friend visa application is applicable in case you are travelling for visiting your family member or friend. This visa is given for travel period of less than 90 days. Visa for family members of EU/Czech Republic National
Cultural Event	You may submit an application under this category of visa when you envisage to participate in cultural, sports or religious events or you are a member of a film crew and you are planning to stay in the Schengen area for a maximum of 90 days.
Tourism	Tourist visa application is applicable in case you are travelling for tourism purposes. This visa is given for travel period of less than 90 days

Cultural Event	You may submit an application under this category of visa when you envisage to participate in cultural, sports or religious events or you are a member of a film crew and you are planning to stay in the Schengen area for a maximum of 90 days.

Cultural Event	You may submit an application under this category of visa when you envisage to participate in cultural, sports or religious events or you are a member of a film crew and you are planning to stay in the Schengen area for a maximum of 90 days.
Tourism	Tourist visa application is applicable in case you are travelling for tourism purposes. This visa is given for travel period of less than 90 days

## **Long Term Visa:**

Applications for visa allowing stay for more than 90 days in the Czech Republic must be submitted personally at the Embassy of the Czech Republic on the date agreed by the Embassy.
